## **Notice of Common Law Assembly**

From: A body of People of Texas wishing to assemble more fully to educate one another about common law and equity and to establish and create a Texas court of record with state-wide geographical jurisdiction, a common law grand jury, and our Second Amendment-protected duly organized county militias.

To: All men and women who understand they are Republic of Texas nationals, not U.S. citizens, who wish to help re-establish Constitutional, common law, non-corporate government for the sovereign republic of Texas, and who live and intend to continue living on the land mass known as Texas a sovereign nation-state since at least March 16, 1836, described herein below:

The boundaries of State of Texas shall be as follows, namely: Beginning at a point on the near Brownsville where the Gulf of Mexico meets the Rio Grand proceeding westward and northwest along the Rio Grand with the border of Mexico until it meets the town of Anthony next to State of New Mexico and then proceeds eastward along the southern border with State of New Mexico until reaches the north south eastern border of State of New Mexico and proceeds north until it reaches highway 412, which from this point proceeds eastward along the southern panhandle border with State of Oklahoma until it reaches the most northeastern point and border with State of Oklahoma near the town of Follet, then proceeding southward until reaching the Red River near Childress and proceeding along the Red River eastward along the southern border with State of Oklahoma and State of Arkansas until reaching the intersection of highway 59 bordering State of Arkansas near Texarkana, then proceeding southward until reaching the Toledo Bend Reservoir bordering State of Louisiana near and just west of the town of Logansport and proceeding down the middle of Toledo Bend Reservoir bordering State of Louisiana until reaching its southern end near the town of River Bedd and proceeding southward along the river known as the Sabine bordering State of Louisiana until reaching Sabine lake bordering State of Louisiana continuing southwestward until reaching the Gulf of Mexico and then proceeding along the Gulf of Mexico until reaching the confluence of the Gulf of Mexico meets the Rio Grande bordering Mexico.

We invite you to join with us if you meet the following qualifications:

- A. Are at least 18 years of age;
- B. Are competent to manage your own affairs;

- C. Agree with Public Law 97-280 enacted by Congress affirming that God's law is the law of the land, and that common law, derived from Magna Carta, is the closest human approximation to the law of God, our Creator.
- D. Recognize that, as one of the people of the Texas republic, you do not meet any definition of being a U.S. citizen, and are willing to demonstrate an understanding by rescinding all voter registration documents by affidavit, rebutting any presumptions of consent to the corporate state;
- E. Are willing to correct your legal and political status by rebutting all fraudulent presumptions created by our birth certificates, which have been used to monetize our personal information without our knowledge or consent;
- F. Are aware that most of the agents of the management corporations acting as our government are prohibited from occupying positions of public trust by the original thirteenth Amendment to the organic Constitution for the united States of America;
- G. Wish to join with other Texian nationals to peacefully and consensually assemble as a juror, or other elected member of a court of record, common law grand jury, and/or associated committees of safety outside the current *de facto* corporate system of statutes, codes, attorneys and corporations, none of which are recognized in the common law as applying to the people not in contract with those entities.
